Dear Mr. Mothopeng

I refer to your email dated 14 August 2020.

This matter has been referred to me by Adv. Mothibi, the Head of the Special Investigating Unit ("the SIU"). He also asked me to respond to you.

I have looked at the relevant allegations and I have also read your founding papers in the proposed Constitutional Court matter.

The SIU is a creature of statute and thus can only operate within the four corners of its founding legislation, which is the Special Investigating Units and Special Tribunals Act, Act 74 of 1996 ("the SIU Act"). The SIU Act determines that the SIU is only mandated to become involved in matters that have been referred to it by way of Proclamation. This is regulated by section 2 of the SIU Act, which deals with referrals by the President, by way of a Proclamation, published in the Government Gazette.

I looked at the issues that you have brought to our attention and I am satisfied that these issues do not fall within the scope and ambit of any existing Proclamation and therefore the SIU is not mandated to become involved in the issues at hand. More particularly, the SIU is not in a position to come to your assistance on the urgent basis that you seek intervention.

I have noticed from your email that you seek the assistance of the Office of the Public Protector (a completely different entity to the SIU). I assume that you have extended a similar approach to them. You are encouraged to pursue that avenue.
