NOTICE OF MOTION

PLEASE TAKE NOTICE that HOLA BON RENAISSANCE
FOUNDATION NPO(hereinafter called the Applicant) intends to make
an application to this Court foran order statingthat:

- 1. Section 129 of the Children's Act 38 of 2005, is inconsistent with the Constitution of the Republic of South Africa, 1996 ('the Constitution') and invalid insofar as it excludes informed consent under pandemic scenarios when en masse medical experiments are conducted on an entire children populace (under the age of 18 and above the age of 12- 'the children'), in the absence of medium and or longitudinal effects of a medical procedure that is unclear and or yet to be determined.
- 2. In terms of Section 129(2), children cannot give informed consent to a medical procedure during pandemic circumstances in en masse medical experiments that do not comply with the Declaration of Helsinki as well as the Second Respondent's 2020. South African Good Clinical Practice: Clinical Trial Guidelines, as

the benefits, risk, social implications of a newly tested medical procedure has not been fully realised and or lack imperative medium to long term study data on the real benefits, risk and social implications, and thus it is against the Constitutional best interest of a child in terms of Section 28(2) of the Constitution which states that 'A child's best interests are of paramount importance in every matter concerning the child".

And for such other ORDER or ORDERS as shall be just and equitable including an order for costs.
