



HBR FOUNDATION MEDIA STATEMENT

28 MARCH 2020 ON THE SETASIDE LOCKDOWN DECISION (COURT CASE) :

South Africa is a great nation, we are a country build on constitutional democracy, on the 28 May 2020. HBR applied to join the urgent application of Liberty Fighter Network to bring an end to #Lockdown. (De Beer, Liberty Fighter Network vs COGTA Case No: 21542/2020) and it was accepted as Amicus Curiae (Friend of the Court)

The South African we represented a united rainbow nation, **wishes of the late**

President Nelson Mandela, The team against lockdown were Hola Bon Renaissance Foundation (Black organisation) Foundation represented by Mr Bontshitswe P Mothopeng), an individual Mr R De Beer (White Person) and Liberty Fighters Network which were led by a Senior council Adv Zenir Omar (Indian) against the State. This day marked a historical moment in the



democratic South Africa, in our unity as a nation we shined, in deed South Africa a blessed nation and great nation. **The Judgment was reserved by Judge Davis**

As the Chairperson of HBR Foundation entered the Pretoria High Court he remembered 17 years ago (2003), when the same court declared him insolvent and his assets including 2 flats in Pretoria and rights were taken away as a young person (26 years), who did not understand what was happening, with no legal assistance as he tried to represent himself and failed, He experience hardship and solder on until he was rehabilitated in 2008 after settling all the debts.



HBR Foundation understand that today's circumstance of Lockdown have declared all black, Indian, colours, white, male, female, young , old , rich and poor, professionals, entrepreneurs, businesses, State we mean all South Africans declared Insolvent and while majority experience poverty

On the 26 March 2020 it approach the Constitutional court on urgent basis to interdict the President on Lockdown, and its matter was dismissed due to **No prospect of success**, in joining the today's Court case it did not bases its argument on media but on facts and presented even a solution for the country though the court.

TAKE NOTE THAT **HOLA BON RENAISSANCE FOUNDATION** made an application to the court for the following order:

- a) Declaring the classification of the national disaster as unfair and procedural unfair
- b) Declaring the classification of the national disaster as unconstitutional
- c) Set-aside the administration decision on disaster Management regulation and lockdown
- d) Nullifying the lock down as invalid
- e) Declaring the Lock down unconstitutional
- f) Setup an independent Lock Down committee to enquiry on
 - i) Setup with atleast 30 experts within the 15 days
 - ii) With powers to independent to investigate all course of death associated with Covid19 and report on all deaths associated with Covid
 - iii) Mandate to verify and qualify the tested database
 - iv) To report to this court every month for a period of a year
 - v) any other mandate the court deems it fit
- g) The State to proceed with all the relief for the next 6 months and with a report presented to the court within the next 15 days of every month
- h) State to maintain its promises and commitment with relief as initially declared to the nation
- i) Restructuring and capacitation of the National Disaster management



HBR support the call of saving lives as fundamental important, and declare that lives are more important and equally so all the right that comes with it's are important, for there is no use to life without rights to life.

In so saying in building our Nation, we further propose a new perspective where the State set aside some resources to continue focuses in saving the elderly and those with underline health condition by putting them in the State Covid19 Free zone environments (State Quarantine Premesis) until the Covid 19 Curb is flatted, while note that Covid 19 act as a catalyst to many death experienced worldwide. As statistics are today we have 0.001% of casualty in a population of 57 million, as we analyse the announcement by our President Ramaphosa on 24 March 2020,

Meaning all health Quarantine areas that have been put in place by the State should warehouse all the elders and these with underline health condition that are vulnerable and need the State intervention and support.

While the country and its economy gears up to towards once upon a promising nation and taking the lessons and advancements which were broad and experienced during this period of Covid 19.

We call all human being in our land to join in pray of the above to realise in building an Africa that we will all be proud to belong to, live in and bear its fruits.
